**On completion and filing of this waiver with the SCSA membership application provider, SCSA Caretaker, or at the SCSA Clubhouse, the MINOR may enter SCSA premises with membership privileges if they are accompanied by an adult who is an SCSA member.** \_\_\_\_\_ (Initial)

Each time an SCSA Junior, Annual/Family, or Life Membership is purchased or renewed, Junior members, or family members listed by the PRIMARY member, must complete, or have completed by their parent or guardian, an SCSA **Spouse Supplemental Membership Waiver** or **Minor Supplemental Membership Waiver**, as appropriate, and file it with the SCSA membership application provider, SCSA Caretaker, or at the SCSA Clubhouse prior to them entering SCSA premises under the membership. Failure to do so will result in cancelation of the Junior, Annual/Family, or Life Membership for all individuals associated with said membership. Clubhouse and Caretaker are not always open. \_\_\_\_\_ (Initial)

Upon entering the premises of the Sheridan County Sportsmen's Association shooting complex, I will abide by all Rules and Regulations. I will maintain and carry firearms in a safe manner. I will conduct myself in a courteous and sportsman-like manner. I will clean up after myself, including removal of targets. I will report any damage which I have caused. I will report safety violations or damages caused by others. \_\_\_\_\_ (Initial)

The SCSA Rules and Regulations may be read on the SCSA website or by request from SCSA. It is the responsibility of all persons associated with a membership and their guests to read and understand the SCSA Rules and Regulations before entering the SCSA premises. \_\_\_\_\_ (Initial)

An SCSA member may bring a non-member guest one (1) time to the SCSA premises (non-member day fees waived). An SCSA **Guest Waiver** must be completed and filed with the SCSA Caretaker or at the SCSA Clubhouse prior to the guest entering SCSA premises. Failure to do so may result in suspension or expulsion from SCSA of the member who brought the guest. Clubhouse and Caretaker are not always open. \_\_\_\_\_ (Initial)

Using SCSA premises for product testing, commercial endeavors, or non-profit organization activities is not allowed without SCSA Executive Committee authorization and is grounds for membership suspension or expulsion from SCSA. \_\_\_\_\_ (Initial)

A PRIMARY member's keycard may only be used by persons listed on the PRIMARY member's application. Allowing or participating in unauthorized use of a membership keycard to enter SCSA premises is grounds for membership suspension or expulsion from SCSA. \_\_\_\_\_ (Initial)

***Upon signing, the person signing assumes and accepts all risk, inherent or known or unknown, in consideration for taking part in activities on the Sheridan County Sportsmen's Association premises and ranges. Signee understands the activities include, but are not limited to, the handling, firing, and discharging of live ammunition and the firing of arrows. Signee agrees to hold harmless Sheridan County Sportsmen's Association and Sheridan County, Wyoming from any liability, harm, property damage, personal injury and death related to or resulting from activities at or on the Sheridan County Sportsmen's Association premises. Signee further indemnifies and holds harmless Sheridan County Sportsmen's Association and Sheridan County, Wyoming for and against all harm, liability, property damage, personal injury and death including costs of defense and attorney fees, to any guest or signee, including family members, occurring on or about the Sheridan County Sportsmen's Association premises.*** \_\_\_\_\_ (Initial)
